**Re:** *Case 11898: Application of The Home-Stake Royalty Corporation for an exception to Division Rule 104.C(1) for a non-standard subsurface oil producing area or drilling window [as defined by Rule 111.A(7)] within a standard 40-acre oil spacing and proration unit comprising the SW/4 NE/4 of Section 5, Township 22 South, Range 37 East, in the Undesignated Brunson-Fusselman Pool that is to be no closer than 330 feet to the south, west, and north quarter-quarter section lines of the SW/4 NE/4 of said Section 5 nor closer than 100 feet to the east quarter-quarter section line of the SW/4 NE/4 of said Section 5. Said unit is to be dedicated to its existing Republic "5" Well No. 1 (API No. 30-025-34043), located at a surface location 1650 feet from the North and East lines (Unit G) of said Section 5, which is approximately 1.5 miles west southwest of Eunice, New Mexico.*



Gentlemen:

The Home-Stake Royalty Corporation hereby withdraws its application for an unorthodox location for the subject well. The well was drilled as a straight hole at a legal location (1,650' FNL & 1,650' FEL Sec. 5-T22S-R37E) to a total depth of 7,610' and failed to encounter prospective Fusselman at this location. The well was plugged back to a depth of 3,170' as specified by Oil & Gas Conservation Division personnel at Hobbs and operations were turned to Zia Energy, Inc. for completion as a shallow San Andres producing well.
