ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on April 3, 1998, at Santa Fe, New Mexico, before Examiner David R. Catanach..

NOW, on this 13<sup>th</sup> day of April, 1998, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Devonian formation, said pool to bear the designation of Northwest Echol-Devonian Pool. Said Northwest Echol-Devonian Pool was discovered by the Cobra Oil and Gas Corporation State 7 Well No. 1 located in Unit P of Section 7, Township 10 South, Range 37 East, NMPM. It was completed in the Devonian formation on September 13, 1997. The top of the perforations is at 12,532 feet.
- (3) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of South Hat Mesa-Delaware Pool. Said South Hat Mesa-Delaware Pool was discovered by the

Bass Enterprises Production Company Hat Mesa Well No. 1 located in Unit D of Section 10, Township 21 South, Range 32 East, NMPM. It was completed in the Delaware formation on September 13, 1997. The top of the perforations is at 8,602 feet.

(4) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Seven Rivers formation, said pool to bear the designation of Littman-Seven Rivers Pool. Said Littman-Seven Rivers Pool was discovered by the D.K. Boyd Oil and Gas Company Inc. Littman 8 Federal Well No. 1 located in Unit N of Section 8, Township 21 South, Range 38 East, NMPM. It was completed in the Seven Rivers formation on December 29, 1996. The top of the perforations is at 3,138 feet.

(5) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of West Pearl-Delaware Pool. Said West Pearl-Delaware Pool was discovered by the Armstrong Energy Corporation Mobil 24 Federal Well No. 1 located in Unit K of Section 24, Township 19 South, Range 34 East, NMPM. It was completed in the Delaware formation on October 25, 1997. The top of the perforations is at 8,130 feet.

(6) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Devonian formation, said pool to bear the designation of West Sawyer-Devonian Pool. Said West Sawyer-Devonian Pool was discovered by the Cobra Oil and Gas Corporation State 16 Well No. 1-Y located in Unit P of Section 16, Township 9 South, Range 37 East, NMPM. It was completed in the Devonian formation on October 5, 1997. The top of the perforations is at 12,551 feet.

(7) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of North Shoe Bar-Atoka Gas Pool. Said North Shoe Bar-Atoka Gas Pool was discovered by the Yates Petroleum Corporation Brunson AQK State Com Well No. 1 located in Unit G of Section 10, Township 16 South, Range 35 East, NMPM. It was completed in the Atoka formation on October 7, 1997. The top of the perforations is at 11,992 feet.

(8) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Devonian formation, said pool to bear the designation of Trinity-Devonian Pool. Said Trinity-Devonian Pool was discovered by the Charles B. Gillespie Jr. Hodge Well No. 1 located in Unit M of Section 27, Township 12 South, Range 38 East, NMPM. It was completed in the Devonian formation on December 15, 1997. The top of the perforations is at 12,133 feet.

(9) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Abo formation, said pool to bear the designation of Northeast

Vacuum -Abo Pool. Said Northeast Vacuum-Abo Pool was discovered by the Primero Operating Inc. Plains Radio State Well No. 1 located in Unit E of Section 23, Township 17 South, Range 35 East, NMPM. It was completed in the Abo formation on November 23, 1997. The top of the perforations is at 9,591 feet.

(10) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Yates formation, said pool to bear the designation of East Warren-Yates Pool. Said East Warren-Yates Pool was discovered by the Stevens & Tull Inc. Kyte Well No. 6 located in Unit I of Section 23, Township 20 South, Range 38 East, NMPM. It was completed in the Yates formation on November 18, 1997. The top of the perforations is at 3,110 feet.

(11) There is need for the contraction of the West Lovington-Pennsylvanian Pool in Lea County, New Mexico, in order to correct nomenclature.

(12) There is need for the contraction of the West Lovington-Strawn Pool in Lea County, New Mexico, in order to include the deleted acreage in the South Big Dog-Strawn Pool.



rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, contractions, and extensions included herein shall be May 1, 1998.
