Dear Mr. Stogner:

Merrion Oil & Gas Corporation recently purchased and now operates the subject well which is currently producing in the Basin Dakota Pool. The well is located within the City of Farmington and has a spacing unit that encompasses literally hundreds of fee leases. While most of these minerals were leased up by Merrion's predecessors, a large number had to be force-pooled prior to drilling the Dakota well.

Merrion now plans to recomplete the Farmington C Com #1 to the Pictured Cliffs Formation. We have made a second effort to obtain leases from the unleased mineral owners or requested they join us as working interest owners in the recompletion. In addition, we have attempted to get some minor working interest owners to sell or join us in the recompletion. We have not been entirely successful. Therefore, Merrion requests your approval for compulsory pooling of these interests for the recompletion of this well based upon terms and conditions which include:

- a.) Merrion Oil & Gas Corp. be named operator;
- b.) Provisions for applicant and all working interest owners to participate in the costs of recompleting, equipping, and operating the well;
- c.) In the event a mineral owner or working interest owner fails to elect to participate, then provision be made to recoup out of production, the costs of the drilling, completing, equipping, and operating the well, including a risk factor penalty of 200%;

- d.) Provisions for overhead rates per month drilling and per month operating and a provision providing for an adjustment method of the overhead rates as provided by COPAS; and
- e.) For such other and further relief as may be proper.

Attached in support of this application is a list of all unleased mineral owners or uncommitted working interest owners who have received copies of this application.

Please let me know if additional information is needed. Please schedule this matter for hearing for Thursday, April 16, 1998.
