




Gentlemen:

This letter is to advise you that David H. Arrington Oil & Gas, Inc. filed the enclosed application with the New Mexico Oil Conservation Division seeking the force pooling of all mineral interests from the surface to the base of the Morrow formation, Townsend-Morrow Gas Pool in Lots 9 through 16 of Section 3, Township 16 South, Range 35 East, NMPM, Lea County, New Mexico. Arrington proposes to dedicate the referenced pooled unit to its proposed Parachute Hopper Well No. 1 to be drilled at a standard location 3510 feet from the South line and 1650 feet from the West line of said Section 3.

This application has been set for hearing before a Division Examiner on June 25, 1998. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.






