

SCOTT E. WILSON AND RICHARD K. BARR d/b/a WILSON & BARR OIL AND GAS EXPLORATION ("Wilson & Barr"), through its undersigned attorneys, hereby makes application to the Oil Conservation Division for an order approving an unorthodox well location, and in support of this application states:


1. Applicant is a working interest owner in the Section 31, Township 20 ½ South, Range 22 East, NMPM, Eddy County, New Mexico, and proposes to drill a well to the Morrow formation, Undesignated Little Box Canyon-Morrow Gas Pool, at an unorthodox gas well location 850 feet from the North line and 300 feet from the West line of said Section 31.
2. Applicant seeks an exception to Rule 104 C(2)(b) of the General Rules and Regulations of the Oil Conservation Division to permit the drilling of this well at this unorthodox gas well location.
3. All of irregular Section 31 should be dedicated to the well.

4. Approval of this application will afford the interest owners in this irregular Section the opportunity to produce their just and equitable share of the reserves under the subject spacing and proration unit and will otherwise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Scott E. Wilson and Richard K. Barr d/b/a Wilson & Barr Oil and Gas Exploration requests that this application be set for hearing before an Examiner of the Oil Conservation Division on July 9, 1998, that notice be given as required by law and the rules of the Division, and that the Division enter its Order granting this application.
