

Enron Oil & Gas Company proposes to drill the STW "2" State Com No. 1 well as an 11,700' Morrow/Chester test at a location 1650' FNL and 1650' FWL of Section 2, T18S, R29E, Eddy County, New Mexico. In this regard please find two (2) AFEs covering this test. Please execute and return one (1) copy should you elect to participate. Upon receipt of your election to join we will forward an Operating Agreement.

In the event you do not choose to participate, Enron would request a Farmout for the drilling of this well on your interest in the W/2 of this Section 2. According to our records you own 100% of the operating rights in the NW/4 NW/4, SW/4 NW/4, E/2 SW/4 excluding the unitized West Loco Hills Grayburg No. 4 Sand. General terms would provide for delivering Enron a 75% NRI with you retaining the difference in the form of a retained ORRI. The Farmout would provide for a 180 day continuous development clause to drill any remaining tract under the same terms.
