On behalf of Santa Fe Energy Resources, Inc., I would appreciate you continuing the referenced case from the Examiner docket schedule for July 9, 1998 until such time as the interest owners have completed the scheduled audit of well costs involved in this matter.


In March, 1997, Santa Fe Energy Resources' Gaucho Unit Well No. 2 was abandoned when substantial circulation was lost while fishing for stuck drill pipe and the rig was then skidded 75 feet and the Gaucho Unit Well No 2-Y was drilled and successfully completed as a producing Atoka gas well. Mr. Landreth went non-consent under the compulsory pooling order issued February 14, 1997. In June, 1998, he now contends that his share of production from the Gaucho Unit Well No. 2-Y should not be used to pay for his share of the costs of the Gaucho Unit Well No. 2.

Santa Fe Energy Resources, Inc. and Southwest Energy Production Company, two of the working interest owners in these wells, have already agreed to an audit of the costs involved which will include allocating those costs between the two wells. I have enclosed a copy of a March 16, 1998 letter to Mr. Landreth in which he also was invited to participate in this audit which is scheduled to commence on August 17, 1998.

I am not aware of any urgency which would require the Division to conduct a "well cost" hearing prior to the conclusion of a "well cost audit" by the working interest owners. In fact awaiting the outcome of an audit will provide the Division and the parties with the appropriate allocation of well costs, will narrow the issues to be adjudicated by the Division and will avoid having the Division hear this matter more than once.
