

Dear Mr. Stogner:

This letter is official notice to you of my objection to the location of the proposed well Turner B #115, with the proposed location of 1050' FNL and 25' FWL, Section 20, Township 17S, Range 31E, for which there is reportedly a permit issued by the BLM to Devon Energy Corporation, Oklahoma City, Oklahoma, operator.

It is my understanding from a certified letter (# Z-100-656-184) that I received from Devon Energy Corporation, dated April 22, 1998 (attached), that this is a non-standard location and approval is required for the drilling of this well from your agency before an allowable will be issued. The Devon Energy Corporation's letter was to serve the required notice to me, as one of the interest owners in the Turner A lease.

After several telephone calls to Devon Energy Corporation and the BLM, I determined it was necessary to register my objection to the location with the Oil Conservation Division of the State of New Mexico. My husband, E. O. West, Jr., is a retired Division Landman from The Superior Oil Company. He and our attorney advise me on these matters.

The reason for my objection is as follows.

The Devon Energy representatives we talked to, Ms. Karen Byers and Mr. Ken Gray, said that the location was chosen to "even things out" among all owners, as they had drilled several "A" wells near the "B" lease line. We believe it would drain the "A" lease under which I own an overriding royalty interest. Devon Energy apparently believes that since the BLM owns all royalty interests under both leases that the rights of the overriding royalty interest owners can be ignored in this operation. When we suggested that a unit be formed around the well so that all owners could participate, the idea was rejected by the Devon Energy representatives over the phone. We would not object if the well was moved 25' on the "A" Lease.

Again, I wish to go on record as expressing my non-approval of this location. Please advise me of the decision that is made regarding this location.
