Gentlemen:

This letter is to advise you that Yates Petroleum Corporation has filed the enclosed amended application with the New Mexico Oil Conservation Division seeking authorization to simultaneously dedicate a standard spacing proration unit in the North Shoe Bar-Atoka Gas Pool comprised of the E/2 of Section 10, Township 16 South, Range 35 East, NMPM, to its Brunson "AQK" Well No. 1 located 2260 feet from the North line and 1795 feet from the East line and its Big Flat "ASN" State Com Well No. 1 located 1650 feet from the South line and 1980 feet from the East line of said Section 10 or, in the alternative, the contraction and expansion of the current boundaries of the North Shoe Bar-Atoka Gas Pool to conform to the spacing units dedicated to the wells in this pool and the adoption of special pool rules and regulations for this pool which authorize a second gas well on each standard 320-acre spacing and proration unit. The North Shoe Bar-Atoka Gas Pool currently includes the N/2 of Sections 10 and 11 of Township 16 South, Range 35 East, NMPM, Lea County, New Mexico.


