APPLICATION OF NADEL AND GUSSMAN PERMIAN, L.L.C. AND WILSON & BARR FOR COMPULSORY POOLING, EDDY COUNTY, NEW MEXICO.

APPLICATION

Nadel and Gussman Permian, L.L.C. and Wilson & Barr apply for an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the N½ of Section 36, Township 20 South, Range 21 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, state:

- 1. Applicants are working interest owners in the N½ of said Section 36, and have the right to drill a well thereon.
- 2. Applicants propose to drill the Little Box State Well No. 3, at an orthodox well location in the SE¼NW¼ of the section, to a depth sufficient to test the Morrow formation, and seek to dedicate the following acreage to the well:
 - (a) The N% of Section 36 to form a standard 320 acre gas spacing and proration unit for any and all formations and/or pools developed on 320 acre spacing within said vertical extent, including but not limited to the Undesignated Loafer Draw-Upper Pennsylvanian Gas Pool, Undesignated Little Box Canyon-Strawn Gas Pool, Undesignated Little Box Canyon-Atoka Gas Pool, and Undesignated Little Box Canyon-Morrow Gas Pool; (b) The NW% of Section 36 to form a standard 160 acre gas spacing and proration unit for any and all formations and/or pools developed on 160 acre spacing within said vertical extent; and

- (c) The SE½NW½ of Section 36 to form a standard 40 acre oil spacing and proration unit for any and all formations and/or pools developed on 40 acre spacing within said vertical extent.
- 3. Applicants have in good faith sought to obtain the voluntary joinder of the mineral interest owners in the N½ of Section 36 for the purposes set forth herein.
- 4. Although applicants attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicants seeks an order pooling all mineral interest owners in the N½ of Section 36, pursuant to NMSA 1978 §70-2-17 (1995 Repl. Pamp.).
- 5. The pooling of all mineral interests underlying the N½ of Section 36, as set forth above, will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, Applicants request that, after notice and hearing, the Division enter its order:

- A. Pooling all mineral interests in the N½ of Section 36, from the surface to the base of the Morrow formation:
- B. Designating Nadel and Gussman Permian, L.L.C. as operator of the well;
- C. Considering the cost of drilling and completing the well, and allocating the cost thereof among the well's working interest owners;

- D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting said rates pursuant to the COPAS accounting procedure;
- E. Setting a penalty for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well; and
- F. Granting such further relief as the Division deems proper.
