




Gentlemen:

This letter is to advise you that Marbob Energy Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval of an unorthodox well location for the Lusk Deep Unit Well No. 1 and the proposed Lusk Deep Unit Well No. 14. Marbob also seeks authorization to simultaneously dedicate a standard 643.47-acre spacing or proration unit in the Lusk-Morrow Gas Pool comprised of Section 19, Township 19 South, Range 32 East, NMPM, to its Deep Lusk Unit Wells 1 and 5 and its proposed Deep Lusk Unit Well No. 14.

This application has been set for hearing before a Division Examiner on November 5, 1998. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. 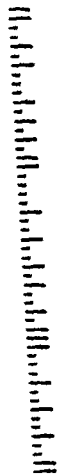

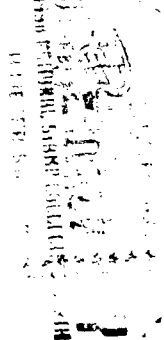
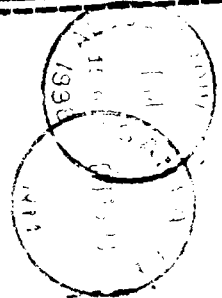
