THE APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING, CONTRACTING VERTICAL AND HORIZONTAL LIMITS, REDESIGNATING AND EXTENDING CERTAIN POOLS IN LEA AND ROOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on December 3, 1998, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 7th day of January, 1999, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Devonian formation, bearing the designation of Cam-Devonian Pool. The Cam-Devonian Pool was discovered by the UMC Petroleum Corporation Hood State Well No. 1 located in Unit F of Section 25, Township 10 South, Range 37 East, NMPM, which was completed in the Devonian formation on March 19, 1998. The top of the perforations is at 11,986 feet.
- (3) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the San Andres formation, bearing the designation of Cary-San Andres Gas Pool. The Cary-San Andres Gas Pool was discovered by the Texaco Exploration & Production Inc. C. P. Falby B Federal Well No. 4 located in Unit L of Section 8,

Township 22 South, Range 37 East, NMPM, which was completed in the San Andres formation on August 20, 1997. The top of the perforations is at 3,960 feet.

- (4) There is need for the creation of a new pool in Lea County, Nev Mexico, for the production of oil from the Devonian formation, bearing the designation of Southeast Crossroads-Devonian Pool was ciscovered by the Marbob Energy Corporation Lewis Fee Well No. 1 located in Unit N of Section 31, Township 9 South, Range 37 East, NMPM, which was completed in the Devon an formation on May 1, 1998. The top of the perforations is at 12,460 feet.
- (5) There is need for the creation of a new pool in Lea County, Nev Mexico, for the production of gas from the Strawn formation, bearing the designation of Fa rview Mills-Strawn Gas Pool. The Fairview Mills-Strawn Gas Pool was discovered by the Burlington Resources Oil & Gas Company Pitchfork 4 Federal Well No. 2 located in Unit K of Section 4, Township 25 South, Range 34 East, NMPM, which was completed in the Strawn formation on May 9, 1998. The top of the perforations is at 13,701 feet.
- (6) There is need for the creation of a new pool in Lea County, Nev Mexico, for the production of gas from the Mississippian formation, bearing the designation of North Feather-Mississippian Gas Pool. The North Feather-Mississippian Gas Pool was discovered by the Yates Petroleum Corporation Pluma ASD State Com. Well No. 1 located in Unit L of Section 10, Township 15 South, Range 32 East, NMPM, which was completed in the Mississippian formation on February 7, 1998. The top of the perforations is a 12,456 feet.
- (7) There is need for the creation of a new pool in Lea County, Nev Mexico, for the production of oil from the Abo formation, bearing the designation of East Garrett-Abo Pool. The East Garrett-Abo Pool was discovered by the Browning Oil Compar y, Inc. Byers Well No. 1 located in Unit C of Section 29, Township 16 South, Range 39 E ist, NMPM., which was completed in the Abo formation on November 5, 1997. The top of the perforations is at 8,271 feet.
- (8) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the San Andres formation, bearing the designation of Northwest Hare-San Andres Pool. The Northwest Hare-San Andres Pool was discovered by the Conoco Inc. Deck Estate 7 Well No. 1 located in Unit L of Section 7, Township 21 South, Range 37 East, NMPM, which was completed in the San Andres formation on April 13, 1398. The top of the perforations is at 4,018 feet.
- (9) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the San Andres formation, bearing the designation of North Hume-San Andres Pool. The North Hume-San Andres Pool was discovered by the Sar ta Fe Energy

Resources, Inc. Humble Hume 5 State Well No. 1 located in Unit W of Section 5, Township 16 South, Range 34 East, NMPM, which was completed in the San Andres formation on February 25, 1998. The top of the perforations is at 4,984 feet.

- (10) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Atoka formation, bearing the designation of S.R.R.-Atoka Gas Pool. The S.R.R.-Atoka Gas Pool was discovered by the Yates Petroleum Corporation Buffalo Wallow LA Com Well No. 1 located in Unit H of Section 21, Township 9 South, Range 32 East, NMPM, which was completed in the Atoka formation on October 21, 1997. The top of the perforations is at 11,242 feet.
- (11) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Abo formation, bearing the designation of Sand Springs-Abo Pool. The Sand Springs-Abo Pool was discovered by the Manzano Oil Corporation Snake Eyes State Well No. 1 located in Unit I of Section 6, Township 11 South, Range 35 East, NMPM, which was completed in the Abo formation on April 1, 1998. The top of the perforations is at 9,086 feet.
- (12) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Morrow formation, bearing the designation of East Triste Draw-Morrow Gas Pool. The East Triste Draw-Morrow Gas Pool was discovered by the Cobra Oil & Gas Corporation State 19 Well No. 1 located in Unit G of Section 19, Township 24 South, Range 33 East, NMPM, which was completed in the Morrow formation on September 25, 1997. The top of the perforations is at 15,174 feet.
- (13) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Seven Rivers formation, bearing the designation of Warren-Seven Rivers Gas Pool. The Warren-Seven Rivers Gas Pool was discovered by the Conoco Inc. Warren Unit Well No. 127 located in Unit P of Section 28, Township 20 South, Range 38 East, NMPM, which was completed in the Seven Rivers formation on April 18, 1998. The top of the perforations is at 3,027 feet.
- (14) There is need for the contraction of the Rhodes-Yates-Seven Rivers Pool in Lea County, New Mexico, in order that the deleted acreage may be included in the Rhodes-Yates-Seven Rivers Gas Pool.
- (15) There is need for the contraction of the vertical limits of the Shoe Bar-Pennsylvanian Pool in Lea County, New Mexico, to include only the Cisco, Canyon and Strawn formations and the redesignation of the pool as the Shoe Bar-Upper Pennsylvanian Pool.

IT IS FURTHER ORDERED THAT:

- (1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.
- (2) The effective date of this order and all creations, contractions of vertical and horizontal limits, redesignations, and extensions included herein shall be January 1, 1999.
