


Nearburg Exploration Company, L.L.C. applies for approval of an unorthodox gas well location in the S½ of Section 28, Township 21 South, Range 35 East, N.M.P.M., Lea County, New Mexico, and in support thereof, states:

1. Applicant proposes to drill its Range State Well No. 2, at an unorthodox gas well location 660 feet from the South line and 990 feet from the East line (Unit P) of Section 28, to a depth sufficient to test the Morrow formation (Undesignated East Gramma Ridge-Morrow Gas Pool). Applicant requests unorthodox location approval for all zones from the top of the Wolfcamp formation to the base of the Morrow formation.

2. Approval of the unorthodox location will prevent waste and protect correlative rights.
