## APPLICATION

Conoco Inc, by its attorneys, Kellahin & Kellahin, applies to the New Mexico Oil Conservation Division for an order amending Rule 6 of the Special Rules for the North Hardy Strawn Pool to increase the depth bracket oil allowable from 600 barrels of oil per day to 900 barrels of oil per day; and in support thereof states:

- 1. On May 19, 1999, the Division entered Order R-11183 in Case 12184 and created the South Hardy-Strawn Pool, later redesignated as the North Hardy-Strawn Pool by Order R-11204.
- 2. On July 12, 1999, the Division entered Order R-11221 and granted Conoco Inc.'s application in Case 12182 for temporary special rules for the North Hard-Strawn Oil Pool including 160-acre oil spacing and proration units and a depth bracket oil allowable of 600 barrels of oil per day.
- 3. This pool is located within portions of Sections 25 and 36, T20S, R37E, and Sections 30 and 31, T20S, R38E, NMPM and is approximately 12 miles south southwest from Hobbs, New Mexico.

4. Based upon data from wells in the pool, Conoco has evidence which

demonstrates that:

(a) the pool is a solution gas drive reservoir;

(b) production at rates up to 900 barrels of oil per day has little or no

effect on the producing GOR which is consistently at or below 2,000

cubic feet of gas per barrels of oil;

(c) wells are capable of effectively and efficiently producing Strawn

formation oil at rates of up to 900 barrels of oil per day which is in

excess of this pool's current maximum oil allowable of 600 barrels of

day and can do so without causing the waste of reservoir energy,

reducing ultimate recovery or impairing correlative rights.

5. Conoco Inc is the only operator in the pool or of Strawn oil wells within one

mile of the pool and in accordance with Division notice rules, Rule 1207.A(4)(b),

notification of this application is not required to any other operator.
