


This letter is to advise you that Yates Petroleum Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking the force pooling of all mineral interests in all formations from the surface to the base of the Atoka formation underlying certain spacing units in the SE/4 of Section 20, Township 7 South, Range 25 East, N.M.P.M., Chaves County, New Mexico. Yates proposes to dedicate these referenced pooled units to its Reinauer "RC" Federal Com. Well No. 3 which it proposes to drill at a standard gas well location in the Atoka formation at a point 1980 feet from the South line and 1000 feet from the East line of said Section 20.

This application has been set for hearing before a Division Examiner on July 22, 1999. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
