Dear Mr. Marks:

We have received your letter of July 23, 1999, wherein you requested our approval for surface commingling of production from the above-captioned wells.

We understand that Marks and Garner needs to transport gas produced from the above captioned wells to GPM's sales line which is a low-pressure central delivery point. You also propose to test each lease every quarter by way of a one-hour vent test.

Since it appears that there will be no loss of revenue to the State of New Mexico's beneficiaries as a result of your proposed operation, your request is hereby approved. Our approval is given with the understanding that the Commissioner of Public Lands reserves the right to amend or withdraw his approval, should this operation prove to be unprofitable to the state at any time in the future. Also, our approval is subject to like approval by the New Mexico Oil Conservation Division and the Bureau of Land Management. Please submit copies of the NMOCD and BLM's approvals.
