APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING, ASSIGNING A DISCOVERY ALLOWABLE, CONTRACTING AND EXTENDING CERTAIN POOLS IN CHAVES, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

#### ORDER OF THE DIVISION

# BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on September 2, 1999, at Santa Fe, New Mexico, before Examiner Mark W. Ashley.

NOW, on this <u>15</u> th day of September, 1999, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner.

#### FINDS THAT:

(1) Due public notice has been given and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Wolfcamp formation, bearing the designation of Southwest Anderson Ranch-Wolfcamp Pool. Further, the discovery well for the Southwest Anderson Ranch-Wolfcamp Pool, the Nearburg Producing Company Rancho Verde 10 State Well No. 1 located in Unit L of Section 10, Township 16 South, Range 32 East, NMPM, is entitled to and should receive a bonus discovery allowable in the amount of 48,940 barrels of oil to be produced over a two-year period. The discovery well was completed in the Wolfcamp formation on July 1, 1999. The top of the perforations is at 9,806 feet.

(3) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Abo formation, bearing the designation of North Apache Spring-Abo Gas Pool. The North Apache Spring-Abo Gas Pool was discovered by the Primero Operating Inc. Apache Spring Federal Well No. 1 located in

Unit F of Section 34, Township 10 South, Range 30 East, NMPM, which was completed in the Abo formation on September 16, 1998. The top of the perforations is at 7 590 feet.

(4) There is need for the creation of a new pool in Roosevelt County, New Mexico, for the production of oil from the San Andres formation, bearing the designation of Northeast Bluitt-San Andres Pool. The Northeast Bluitt-San Andres Pool was discovered by the Manzano Oil Corporation Appaloosa Federal Well No. 1 located in Unit J of Section 35, Township 7 South, Range 37 East, NMPM, which was completed in the San Andres formation on November 10, 1998. The top of the perforations is at 4,433 feet.

(5) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Atoka formation, bearing the designation of Cross Bough-Atoka Gas Pool. The Cross Bough-Atoka Gas Pool was discovered by the Reliance Operating Company Federal D Well No. 3 located in Unit O of Section 31, Township 9 South, Range 36 East, NMPM, which was completed in the Atoka 'ormation on August 21, 1998. The top of the perforations is at 11,133 feet.

(6) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Delaware formation, bearing the designation of Northeast Cruz-Delaware Pool. The Northeast Cruz-Delaware Pool was discovered by the Yates Petroleum Corporation Quay AQU State Well No. 1 located in Unit C of Section 10, Township 23 South, Range 33 East, NMPM, which was completed in the Delaware formation on May 27, 1997. The top of the perforations is at 8,865 feet.

(7) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Delaware formation, bearing the designation of Southwest Diamondtail-Delaware Pool. The Southwest Diamondtail-Delaware Pool was discovered by the Concho Resources Inc. Tomcat 16 State Well No. 2 located in Unit M of Section 16, Township 23 South, Range 32 East, NMPM, which was completed in the Delaware formation on May 3, 1999. The top of the perforations is at 8,444 feet

(8) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Devonian formation, bearing the designation of East Dublin-Devonian Pool. The East Dublin-Devonian Pool was discovered by the Yates Petroleum Corporation Ed Powell Unit Well No. 2 located in Unit N of Section 7, Township 26 South, Range 38 East, NMPM, which was completed in the Devonian formation on August 18, 1997. The top of the perforations is at 10,010 feet.

(9) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the San Andres formation, bearing the designation of West Eunice-San Andres Gas Pool. The West Eunice-San Andres Gas Pool was discovered by the Texaco E&P Inc. V M Henderson Well No. 16 located in Unit E of Section 30, Township 21 South, Range 37 East, NMPM, which was completed in the San Andres formation on January 2, 1998. The top of the perforations is at 4,035 feet.

(10) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Abo formation, bearing the designation of Hightower-Abo Gas Pool. The Hightower-Abo Gas Pool was discovered by the Toco LLC Tower

Well No. 1 located in Unit N of Section 23, Township 12 South, Range 33 East, NMPM, which was completed in the Abo formation on February 11, 1999. The top of the perforations is at 8,400 feet.

(11) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Canyon formation, bearing the designation of Kemnitz-Canyon Pool. The Kemnitz-Canyon Pool was discovered by the Kaiser Francis Oil Company TCH Ranch 6 Well No. 1 located in Unit X of Section 6, Township 16 South, Range 34 East, NMPM, which was completed in the Canyon formation on February 3, 1999. The top of the perforations is at 11,482 feet.

(12) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Morrow formation, bearing the designation of Klein Ranch-Morrow Gas Pool. The Klein Ranch-Morrow Gas Pool was discovered by the Louis Dreyfus Natural Gas Toro 33 State Well No. 1 located in Unit G of Section 33, Township 19 South, Range 35 East, NMPM, which was completed in the Morrow formation on February 24, 1999. The top of the perforations is at 12,864 feet.

(13) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Morrow formation, bearing the designation of North Shoe Bar-Morrow Gas Pool. The North Shoe Bar-Morrow Gas Pool was discovered by the Yates Petroleum Corporation Field APK State Com Well No. 3 located in Unit K of Section 2, Township 16 South, Range 35 East, NMPM, which was completed in the Morrow formation on February 18, 1999. The top of the perforations is at 12,301 feet.

(14) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Glorieta formation, bearing the designation of Teague-Glorieta Gas Pool. The Teague-Glorieta Gas Pool was discovered by the Arch Petroleum, Inc. C E Lamunyon Well No. 41 located in Unit M of Section 21, Township 23 South, Range 37 East, NMPM, which was completed in the Glorieta formation on April 1, 1998. The top of the perforations is at 5,052 feet.

(15) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Delaware formation, bearing the designation of Teas-Delaware Pool. The Teas-Delaware Pool was discovered by the Shackelford Oil Company Tonto Federal Well No. 1 located in Unit H of Section 10, Township 20 South, Range 33 East, NMPM, which was completed in the Delaware formation on February 12, 1998. The top of the perforations is at 6,524 feet.

(16) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of oil from the Wolfcamp formation, bearing the designation of Vest Ranch-Wolfcamp Pool. The Vest Ranch-Wolfcamp Pool was discovered by the Manzano Oil Corporation S V Vest State Well No. 1 located in Unit N of Section 16, Township 14 South, Range 30 East, NMPM, which was completed in the Wolfcamp formation on May 8, 1999. The top of the perforations is at 7,888 feet.

(17) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Bone Spring formation, bearing the designation of South Wilson-Bone Spring Gas Pool. The South Wilson-Bone Spring Gas Pool was

discovered by the V-F Petroleum Inc. Merchants A Well No. 1 located in Unit L of Section 30, Township 21 South, Range 35 East, NMPM, which was completed in the Bone Spring formation on January 15, 1999. The top of the perforations is at 8 422 feet.

(18) There is need for the contraction of the Anderson Ranch-Wolf camp Pool in Lea County, New Mexico, in order to correct nomenclature.

(19) There is need for the contraction of the North Monument-Abo Pool in Lea County, New Mexico, in order to place the deleted acreage in the Monument-Abo Pool.

#### IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division with n that 60day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, contractions, as signments of discovery allowables, and extensions included herein shall be October 1, 1999.
