APPLICATION

Maralo, LLC applies for an exception to Division Rules 305 and 309 to permit (i) production of casinghead gas without separately metering production, (ii) lease commingling, and (iii) a central delivery point for gas production, and in support thereof, states:

1. Applicant is the operator of federal leases covering the SE $\frac{1}{4}$ NE $\frac{1}{4}$ and SE $\frac{1}{4}$ of Section 13, Township 18 South, Range 32 East, N.M.P.M., as to the West Corbin-Delaware Pool. Interest ownership varies in the leases.

2. Applicant proposes to commingle gas production from the West Corbin-Delaware Pool from 5 wells located on the subject leases and lands, and deliver it to a central delivery point to be located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ (Unit P) of Section 13, without separately metering production, by allocating gas production to each well and to each lease on the basis of monthly well tests. The wells involved are as follows:

3. Notice of this application has been given to all interest owners in the leases, by certified mail.

4. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.
