TO OPERATING AGREEMENT (GSA-16)
DATED NOVEMBER 27, 1951

This Agreement, made and entered into this xxnd day of May, A.D. 1956, by and between BROCKHAVER OIL COMPANY, a Delaware corporation, whose address is P. O. Box 396, Scottsdale, Arizona, (hereinafter referred to as "Brookhaven") and EL PASO NATURAL GAS COMPANY, a Delaware corporation whose address is P. O. Box 1492, El Paso, Texas, (hereinafter referred to as "El Paso")

W I T N E S S E Y H :

WHEREAS, by written Agreement dated November 27, 1951, Brookhaven entered into an Operating Agreement with the San Juan Production Company and the interest of San Juan Production Company has been assigned to El Paso and El Paso has assumed the obligations of San Juan Production Company; and

WHEREAS, a number of Supplements have been made to the Agreement of November 27, 1951, incorporating additional properties into said Agreement; and

WHEREAS, the parties desire to subject the hereinafter described tract of land to the terms and provisions of said Operating Agreement without obligating Brookhaven to pay any costs for drilling or developing said tract to the base of the Mancos Shale.

NOW, THEREFORE, in consideration of the promises and the hereinafter contained promises and agreements, the receipt and sufficiency of which are hereby mutually acknowledged, the parties

hereto agree as follows:

1. New Mexico State Oil and Gas Lease, Serial Number E-4500, insofar as it covers the Southeast Quarter of the Northwest Quarter (SE/4 NW/4) of Section 36, Township 26 North, Range 13 West, S.R.P.M., San Juan County, New Mexico, which said lease is now in full force and effect and is owned by Brockhaven, is hereby subjected to the terms and provisions of said Operating Agreement except that as to the tract of land and lease hereby subjected to said Operating Agreement, El Paso and Brockhaven agree that El Paso shall pay, without right of reimbursement from Brockhaven, all costs of drilling, completing and equipping well or wells drilled to the base of the Mancos Shale on the above described tract or any tract whereof the above tract is a communitized or unitized part.

2. Except as hereby modified and supplemented, the Operating Agreement shall continue in full force and effect.
