1 WHEREUPON, the following proceedings were had at
2 9:00 a.m.:

3 CHAIRMAN WROTENBERY: We can get started now.
4 This is the regular monthly meeting of the Oil Conservation
5 Commission. We're here in the OCD conference room in Santa
6 Fe, New Mexico. It's about 9:00 a.m. on Wednesday, April
7 26th, 2000.

8 I'm Lori Wrotenbery, I chair the Oil Conservation
9 Commission.

10 To my right is Commissioner Jami Bailey, she
11 represents Commissioner Ray Powell on the Oil Conservation
12 Commission.

13 To my left is Dr. Robert Lee, Commissioner.

14 And we have a new legal counsel we want to
15 introduce to everybody. I think he's had an opportunity to
16 meet everybody in the room at this point, but Steve Ross
17 has joined the Oil Conservation Division and, among other
18 things, will be representing the Oil Conservation
19 Commission at their meetings.

20 We also, of course, have Florene Davidson the
21 Commission secretary, and Steve Brenner will be recording
22 the meeting for us today.

23 We have basically three main items on the agenda
24 today, but first we need to go ahead and adopt the minutes
25 of the last Commission meeting, which was held on March

1 24th, 2000.

2 Commissioners, I believe you've had a chance to
3 review the minutes of the March 24th meeting?

4 COMMISSIONER BAILEY: Yes, I have, and I move
5 that we adopt them.

6 COMMISSIONER LEE: Second.

7 CHAIRMAN WROTENBERY: All in favor say "Aye".

8 COMMISSIONER BAILEY: Aye.

9 COMMISSIONER LEE: Aye.

10 CHAIRMAN WROTENBERY: Aye. Okay, I've signed
11 those minutes on behalf of the Commission.

15 cases on the Commission docket for today. Both of those
16 cases have been continued at the request of the *de novo*
17 Applicant.

18 One was Case 12,008. This was the Application of
19 Robert E. Landreth for a determination of reasonable well
20 costs in Lea County, New Mexico. This case will be
21 continued to the May meeting of the Commission, which I
22 believe will occur on May 31st.

23 And the other case was Case 12,299. This is the
24 Application of Redwolf Production, Inc., for compulsory
25 pooling in San Juan County, New Mexico. And at the request

1 of the *de novo* Applicant, this case is being continued to
2 the Commission's meeting on June 23rd, 2000.


