(2) It is understood that Doyle Hartman reserves the right to object to future applications for simultaneous dedication, if and/or when it becomes apparent that Raptor's proposed spacing is more dense that the drainage capability of an efficiently completed Jalmat well, thus (a) violating the correlative rights of offset leases, or (b) promoting waste by requiring the drilling and completion of an excessive number of wells, in order to counter drainage by Raptor.

Please <u>promptly</u> let us know if the conditions of our approval are acceptable to Raptor. If our conditions are not acceptable, this letter shall serve as Doyle Hartman's timely objection to Raptor's application.
