Dear David:

Per our phone conversation yesterday, Chesapeake Operating is actively implementing the WTU waterflood project. We have drilled three infill wells, done a number of workovers, and are beginning well conversions next week. We have begun ditching and laying injection line in the field. We hope to commence water injection by mid-May and will advise you per your request as to this target date.

Regarding conversions, the order permits conversion of the 433, 444, 921, 912, 942, and 641. We have elected to not convert the 444 and 942 upon initial implementation of the flood and will file for their conversion in the future if the flood warrants. We are planning on converting the 913 and 941 in the very near future and will be filing C108s with your office shortly. We also intend to convert our three new wells, the 443, 924, and 945 in the near term and will be submitting C108s for them as well.

I have included a spreadsheet of former names of the WTU wells for your reference. Please call or email if I can answer any additional questions or concerns you may have.
