WHEREUPON, the following proceedings were had at 1 11:35 a.m.: 2 EXAMINER STOGNER: Call next case, Number 12,345, 3 which is in the Application of the Oil Conservation 4 5 Division for an order requiring A.P.A. Development, Inc., 6 to plug three certain wells in San Juan County, New Mexico. 7 At this time I'll call for appearances. 8 MS. HEBERT: May it please the Examiner, my name 9 is Lyn Hebert. I'm appearing for the Oil Conservation 10 Division, and I have one witness to be sworn. I don't know 11 if you are going to need to re-swear him? COURT REPORTER: 12 EXAMINER STOGNER: Let the record show that Mr. 13 Perrin has been previously sworn in Case Number 12,344. 14 15 CHARLIE T. PERRIN, 16 the witness herein, having been previously duly sworn upon 17 his oath, was examined and testified as follows: 18 DIRECT EXAMINATION BY MS. HEBERT: 19 Mr. Perrin, would you state your name for the 20 0. record, please? 21 Charlie T. Perrin. 22 Α. And where do you work and how long have you 23 worked there? 24 I work for the New Mexico Oil Conservation Aztec 25 Α.

I've been with the OCD for eight years. Office. 1 And what is your position with OCD? 2 Q. I'm the senior field oil and gas inspector. 3 Α. And have you previously qualified as an expert in 4 Q. plugging oil and gas wells in New Mexico? 5 Α. Yes, I have. 6 MS. HEBERT: I would ask the Examiner to take Mr. 7 Perrin as an expert in plugging wells in the State of New 8 Mexico. 9 EXAMINER STOGNER: Okay, I can do that, even in 10 San Juan County, New Mexico, I'll accept Mr. Perrin's 11 qualifications. 12 Thank you, Mr. Examiner. 13 THE WITNESS: EXAMINER STOGNER: Let the record show that 14 15 everybody left the room. 16 (Laughter) 17 MS. HEBERT: This is a much more exciting case. (By Ms. Hebert) Mr. Perrin, I'm handing you 18 Q. what's marked as OCD Exhibit Number 1. Are these the 19 20 history of the three wells in question that you pulled from the files in the District's Office? 21 Yes, ma'am, they are. 22 And could you give us a brief history of these 23 wells, so far as when they were drilled and what their 24

production was and when their last production was?

25

- 5 Yes, ma'am. These wells were drilled in 1978. 1 Α. They're approximately 5800 foot deep. They're to the 2 Entrada formation. The last reported production was 1994-3 95. 4 Mr. Perrin, I'm handing you what's been marked as 5 Q. OCD Exhibit Number 2. Are these your recommended plugging 6 7 procedures for these three wells? Yes, ma'am, they are. Α. And again, we have one set of photographs for the 9 Q. new wells in question. Could you give the Examiner an idea 10 of the conditions of these wells at this time? 11 Yes, ma'am. These wells are also abandoned. 12 of them is leaking to the surface, it has visible oil. 13 There also is environmental concerns at the tank battery, 14 15 due to the standing fluid. 16 Is it your recommendation that these wells be 17 plugged and abandoned to prevent waste, protect correlative rights and to otherwise protect the environment? 18 Yes, ma'am, it is. 19 Are you familiar with the bonds that exist on 20 these three wells? 21 Yes, ma'am. 22 Α.
 - Q. I'm handing you what's been marked as Oil
 Conservation Exhibit 3a, -b and -c. Could you describe for
 the Examiner what bonds exist for the three wells?

- A. Yes, ma'am, there are two bonds that exist,
 they're both \$7500 bonds. They exist on the Barbs 1 and
 the Leggs 2. There is no bond on the Santa Fe Leggs Number

 1.
 Q. And is that well the saltwater injection well?
- 6 A. Yes, ma'am.

- Q. Are these bonds cash bonds?
- 8 A. Yes, ma'am.
 - Q. And are they at the First National Bank in Farmington?
- 11 A. Yes, ma'am, they are.
- Q. Finally, I'm handing you what's been marked as

 OCD Exhibit Number 4. This is an affidavit again from Rand

 Carroll.
 - Are you familiar with the efforts that have been made to contact the former operator, A.P.A. Development, and the holder of the cash deposits, First National Bank of Farmington?
- 19 A. Yes, ma'am, I am.
 - Q. And do these attachments to this affidavit indicate that A.P.A. Development refused acceptance of the notice that was sent to them for this hearing?
 - A. Yes, ma'am, they did.
- Q. And the Application, excuse me.
- 25 A. (Nods)

And do the records indicate that the First Q. 1 National Bank of Farmington did receive notification of the 2 Application of this proceeding? 3 Yes, ma'am, they did. 4 5 MS. HEBERT: Thank you. I move for admission of OCD Exhibits 1 through 5 in this matter. 6 EXAMINER STOGNER: Exhibits 1 through 5 will be admitted into evidence. 8 9 EXAMINATION BY EXAMINER STOGNER: 10 11 Q. Mr. Perrin, was one of these wells an injection 12 well? 13 Yes, sir, it was. 14 Q. And was it a -- It was saltwater disposal also 15 into the Entrada? 16 Α. Yes, sir. 17 What's your records show on when that well quit Q. disposing of water? 18 I have no reported injection at all. 19 Α. 20 Oh, okay. So are you saying that it never Q. injected or you don't know --21 Α. I'm saying there was nothing reported. 22 23 What's the general area around these particular Q. wells? 24

These wells are located just outside of the Chaco

25

Α.

Monument, Chaco National Monument Park. They're just south, which is east and north of a small community. I believe it is -- I'm going to say Nageesi.

- Q. Can it be seen from the road?
- A. No, sir, it cannot. They can be seen from the road going into the monument, not the main highway, not Highway 44.
- Q. Okay, then you're talking about the road coming off of 44 --
 - A. That goes to Chaco National Monument, yes.
 - Q. They can be seen from that road?
- 12 A. Yes, sir.

- Q. Nice representation of New Mexico's beauty.

 That's not a question. I made a comment.
 - Now, has there been anybody approach the District Office about taking over the operations of these wells?
 - A. I understand there's been a contact made to Ms. Hebert.

MS. HEBERT: Mr. Examiner, I have received two phone calls. I have not returned them -- I haven't had the chance to return them -- from Mr. Jeff Einardt, who apparently operated the wells that were on the Navajo reservation that are not a subject of this proceedings. He has indicated an interest in possibly trying to recomplete, I believe, is what he said.

I believe the District's recommendation is to, again, have an order from the Examiner ordering that these be plugged and abandoned, but having Mr. Einardt deal with the District as to any possible recompletion in a timely fashion.

EXAMINER STOGNER: So there has been some interest.

- Q. (By Examiner Stogner) Mr. Perrin, I'm looking at a picture of a -- Actually, it looks like a nice size, a metal building with a tank attached to it, with what appears to be a pulling unit in the background. Is that on the lease?
- A. Yes, sir, that unit has also been robbed from.

 The battery and various pieces of it is also gone. The building encompasses two pumps, injection pumps.
 - Q. What would become of this equipment?
- A. This would be salvaged to help offset the expense of plugging.
- Q. And that would go toward whoever was hired or who got the contract?
 - A. Yes, whoever was awarded the bid, correct.
- Q. Here's an interesting picture here of a gentleman
 by a wellbore.
 - A. Yes.

Q. Who is that?

1	A. That's Mr. Denny Foust.
2	Q. Is he with the OCD?
3	A. Yes, he is. He's the environmentalist.
4	Q. Is this well leaking gas or anything?
5	A. No, the well is leaking oil. It is seeping
6	between the tubing and the wellhead cap.
7	Q. So the expression on this gentleman's face is not
8	being overcome by any gas fumes or anything? That's his
9	normal look?
10	A. Yes, sir, I'm afraid so.
11	EXAMINER STOGNER: Okay. Anything further in
12	Case Number 12,345?
13	MS. HEBERT: No, Mr. Examiner, that's all. We
14	request that the order be issued, ordering these wells
15	plugged and abandoned.
16	EXAMINER STOGNER: This case will be taken under
17	advisement.
