
*Application of Matador E & P Company to establish infill well procedures and

At the conclusion of the hearing, you continued this case to the April 6, 2000 Examiner's docket for the sole purpose of providing notice to Enron Oil & Gas Company which is still shown as the operator of the Brinninstool 21 F Well No. 1 located in Unit O of Section 21, T25S, R33E, Lea County, New Mexico which the Division ordered to be plugged in 1995.

Reference is made to the notice received by EOG Resources, Inc. that Matador E&P Company had filed application to amend the Special Rules and Regulations of the Red Hills Wolfcamp Gas Pool. Such case being given NMOC Case Number 12355 and notice for which was received by EOG Resources, Inc. on March 28, 2000.

EOG Resources, Inc. waives any objection to amending the Special Rules and Regulations of the Red Hills-Wolfcamp Gas Pool as follows:

- 1) Amend Rule 2 to provide that a second well be drilled within a standard 640 acre spacing unit, but on a governmental quarter section not containing a first well, and
- 2) Amend Rule 4 to conform the well location rules to Division 104. c (2).
