

## Gentlemen:

In accordance with the provisions of Division Order No. R-11374-A entered on June 19, 2001, which order extended for one year the temporary special pool rules for the Southeast Arena Blanca – Entrada Pool in Sandoval County, New Mexico, including provisions for 160-acre spacing units and designated well locations, the Oil Conservation Division is reopening Case No. 12387 in order that the operators in the Southeast Arena Blanca-Entrada Pool may appear and show cause why the temporary special rules for the pool should not be rescinded and the pool developed on standard 40-acre oil spacing.

This case will appear on the docket for the Examiner Hearing to be held on June 13, 2002. This hearing will be held in the Oil Conservation Division Hearing Room, 1220 S. St. Francis Drive, Santa Fe, New Mexico, at 8:15 a.m. A copy of the advertisement for the June 13 hearing is enclosed.
