

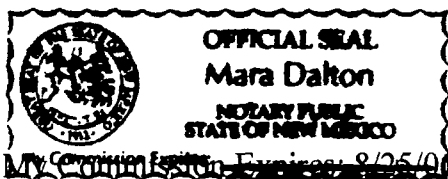

This letter is to advise you that Paladin Energy Corp. has filed the enclosed application with the New Mexico Oil Conservation Division seeking the compulsory pooling of certain spacing and proration units in the NE/4 SE/4 of Section 34, Township 16 South, Range 38 East, NMPM, Lea County, New Mexico. Said units will be dedicated to Paladin's proposed W. W. Hamilton "A" Well No. 2 which it proposed to drill at a standard location in the NE/4 SE/4 of said Section 34 to test all formations to the base of the Devonian formation developed on 40-acre spacing units.

This application has been set for hearing before a Division Examiner on August 10, 2000. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

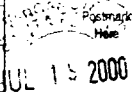

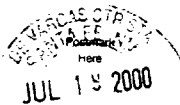
