Ladies and Gentleman:

On March 30th, 2000, Harvey E. Yates Company (HEYCO) sent letters to all of the potential Working Interest Owners (WIOs) in a W/2 Proration Unit for the above captioned well. The location of the well in our previous letter was 660'FSL & 1980' FWL of Section 8; however, when we staked the well, it was located in Anadarko's pipe yard, so we had to move the location 200' to the north of the original location, giving the new location of the well at 860' FSL & 1980' FWL. The response from the letters sent out on March 30th has been very favorable; therefore, HEYCO has prepared and encloses for your review an operating agreement covering the W/2 of Section 8 along with an AFE for the drilling of the Poco Loco 8 Federal Com #1 well. The Exhibit "A" is labeled "temporary" as we expect to be making some changes and/or corrections to the working interests (if necessary) at a later date.

After you have reviewed the enclosures, and you wish to join in the drilling of the Poco Loco 8 Federal Com. #1, please execute the extra set of signature pages to the operating agreement and one copy of the AFE, where indicated, and return both to me. Also include a list of the well information you wish to receive when the well is drilled. Should you not wish to join, but be willing to farmout your interest, retaining an ORRI of 25%, proportionately reduced to your interest (inclusive of the existing royalty and overriding royalty), without a back-in, please notify me. We would appreciate your decision and the return of the signed AFE and JOA signature pages within thirty (30) day of receipt.
