This acreage was previously unitized by Paladin Energy Corporation and the Paladin State "C" Well No. 3 was drilled thereon to test the Devonian formation. The well was a dry hole and Manzano now seeks to re-unitize the area for the purpose of attempting to re-enter the existing wellbore and the directionally drill in an attempt to achieve commercial production. A plat showing the unit boundaries and the location of the directional well is enclosed.

Manzano has acquired a portion of the interest of Paladin Energy Corporation in this acreage and proposes to re-enter the former Paladin well (now the Manzano New Mexico C Well No. 3) at the previously approved unorthodox surface location 1550 feet from the North line and 10 feet from the West line (Unit E) of Section 36. Manzano plans to kick off the well and directionally drill in a south southwesterly direction and complete the well in the Devonian formation, King-Devonian Pool, at an unorthodox gas well bottomhole location 2400 feet from the North line and 190 feet from the East line (Unit H) of Section 35. The bottomhole location of this well encroaches on the offsetting tract to the south which is operated by Yates Petroleum Corporation.

This unit will be the first unit subject to approval under a new State Land Office procedure for "Development Units". In preliminary contacts with the State Land Office, Manzano was directed to obtain a waiver from Yates as the offsetting operator toward whom the well's bottom hole will encroach. Accordingly, Manzano Oil Corporation requests that you waive objection to this application by signing the copy of this letter on the line provided and returning it to me in the enclosed envelope.
