STATEMENT OF CASE

APPLICANT

Applicant, in accordance with Rule 303.C(4), seeks to establish a downhole commingling reference case to provide for (a) compatibility criteria, (b) pressure criteria, (c) cross-flow criteria, (d) prorationing criteria, (e) value criteria, and (f) a modification of notification rules on an area-wide basis authorization for downhole commingling of Fruitland Coal, Pictured Cliffs, Gallup, and Dakota gas production in the wellbores existing or future wells drilled anywhere within the Gallegos Canyon Unit Area located in Townships 27, 28 and 29 North, Ranges 11, 12 and 13 West, NMPM. The center of said area is located approximately 5 miles southeast of Farmington, New Mexico.

BP Amoco will present a status report on its recent negotiations with Mr. Crawford and will address concerns expressed at the December 21, 2001 hearing concerning the way BP proposes to complete wells in the Gallegos Canyon Unit if commingling is approved.




