Ladies & Gentlemen:


Harvey E. Yates Company (HEYCO) proposes to drill and operate the Power 31 Fed. Com #1 well at a location 660' FSL and 660' FEL of Section 31, T-17S, R-31E, Eddy County, New Mexico. The S/2 of Section 31 will be the spacing unit for the proposed 11,850' Morrow test.

We invite each working interest owner to participate in the drilling of the well. Enclosed is HEYCO's joint operating agreement (JOA), extra set of signature and acknowledgment pages to the JOA, and two copies of the drilling AFE. Please sign, date and return the extra set of signature pages and one original of the AFE to me at your earliest opportunity. HEYCO would like to drill the well as soon as a rig is available, so include your well information requirements list as well.

If you decide not to participate in the well, HEYCO will farm in your interest under the JOA contract area on the basis of delivering a 75% net revenue interest to HEYCO with the option at payout to convert your reserved overriding royalty interest to a 25% working interest, subject to proportionate reduction.
