Dear Ms. Wrotenbery:

By letter dated June 22, 2001, the Division granted an extension until October 1, 2001 for David H. Arrington Oil & Gas, Inc. to commence drilling under the above referenced order. Since that time, the de novo appeal filed by Energen Resources has been dismissed, but Arrington has encountered difficulties in scheduling a rig for the well.

Arrington intends to drill the Disco Midge Well No. 1 in the W/2 of Section 35, T-15-S, R-35-E. However, because of delays encountered in obtaining a rig, Arrington will not be able to commence drilling prior to the October 1, 2001 Accordingly, Arrington requests an additional 90-day extension of Order No. R-11568 to January 1, 2002.
