

In September of 2000 the WA Ramsay NCT A #43 well in the adjoining lease (T:21S R:36E S:27) was worked over in the Eumont with a fracture stimulation. This is the ninth Eumont gas well in the 640-acre WA Ramsay NCT A lease. Two of the wells are direct offsets to the WA Ramsay NCT A #43 to the East, West and a third is diagonally offset to the Southwest (Figure 1). There is a dip in production in August, this is due to the El Paso line explosion that caused production to be shut down for 2 weeks. The WA Ramsay #42 is completed lower in the Eumont (Queen and Penrose) and has experienced some difficulty recovering from the El Paso Shut down. The WA Ramsay #44, #46, and #43 are all completed in the same interval and have not seen adverse affects to production from the recompletion of the WA Ramsay NCT A #43 (Figure 2). The lease production has shown an increase in production and reserves from the WA Ramsay NCT A lease that would otherwise have gone undeveloped (Figure 3).

The WA Ramsay lease is analogous to the **H. L. Leonard** lease and the same increased Gas production and increased reserves response is expected in **the H. L. Leonard** Lease. The Geology for the WA Ramsay lease is similar to the **H. L. Leonard** lease of the proposed new well location and therefore an additional well location is necessary to efficiently and economically drain the proration unit to prevent waste and protect correlative rights.




