- Section 5: SE/4SW/4 A Tax Lien transfer was made from the NM Tax and Revenue Depart. to Robert O. Dimmick. Under Del. Acct #0402164888. Dimmick subsequently conveyed this Lien to Quang Le of 2925 Vista Creek Drive San Jose' Ca. 95133. This was in 1993. Need to investigate prior to leasing.
- Section 5: Lots 3&4  
(N/2NW/4) Under the Bankruptcy of Stevens Oil Company there was reference to a Skinner Well. Looking at maps it appears to be a well located in Section 8. This needs further review since it has appeared in a conveyance of ORRI in Book 760 Page 708 (see attached) in SE/4NW/4 of Section 5 and other references in the Stevens bankruptcy.
