



Re: Case No. 12623: Application of Raptor Resources, Inc. for two unorthodox infill gas well locations and simultaneous dedication, Lea County New Mexico.

Ladies and Gentlemen:

This letter is to advise you that Raptor Resources, Inc. has filed the enclosed application with the New Mexico Oil Conservation Division seeking an exception to the well location requirements provided by the "Special Rules and Regulations for the Jalmat Gas Pool", as promulgated by Division Order No. R-8170, as amended, for its proposed State "A" A/C-1 Well No. 130 to be drilled and completed in the Jalmat Gas Pool at an unorthodox infill gas well location 660 feet from the South and East lines (Unit P) and its proposed State "A" A/C-1 Well No. 131 to be drilled and completed in the Jalmat Gas Pool at an unorthodox infill gas well location 1980 feet from the South line and 660 feet from the East line (Unit I) of Section 9, Township 23 South, Range 36 East, NMPM, Lea County, New Mexico.

Raptor Resources, Inc., pursuant to the "Special Rules and Regulations for the Jalmat Gas Pool" and the Stipulated Declaratory Judgment issued by the First Judicial District Court in Santa Fe County, New Mexico, on December 15, 2000, in Cause No. D-0101-CV9902927, seeks authority to simultaneously dedicate the Jalmat production from these proposed new infill wells and the existing Jalmat gas wells identified in the enclosed application to a previously approved non-standard 520-acre spacing and proration unit in the Jalmat Gas Pool (Order No. R-9073) comprised of the S/2 NE/4, N/2 SE/4, and the SE/4 SE/4 of Section 9 and the W/2 of Section 10, Township 23 South, Range 36 East, NMPM.


This application has been set for hearing before a Division Examiner on April 19, 2001. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.
