Re: <u>Case No. 12624</u>: Application of Raptor Resources, Inc. for an unorthodox infill gas well location and simultaneous dedication, Lea County New Mexico.

#### Ladies and Gentlemen:

This letter is to advise you that Raptor Resources, Inc. has filed the enclosed application with the New Mexico Oil Conservation Division seeking an exception to the well location requirements provided by the "Special Rules and Regulations for the Jalmat Gas Pool", as promulgated by Division Order No. R-8170, as amended, for its proposed State "A" A/C-1 Well No. 133 to be drilled and completed in the Jalmat Gas Pool at an unorthodox infill gas well location 660 feet from the North and West lines (Unit D) of Section 24, Township 23 South, Range 36 East, NMPM, Lea County, New Mexico.

Raptor Resources, Inc., pursuant to the "Special Rules and Regulations for the Jalmat Gas Pool" and the Stipulated Declaratory Judgment issued by the First Judicial District Court in Santa Fe County, New Mexico, on December 15, 2000, in Cause No. D-0101-CV9902927, seeks authority to simultaneously dedicate the Jalmat production from this proposed new infill well and the existing Jalmat gas wells identified in the enclosed application to a previously approved non-standard 480-acre spacing and proration unit in the Jalmat Gas Pool (Order No. R-9073) comprised of the W/2 and SE/4 of Section 24, Township 23 South, Range 36 East, NMPM.

This application has been set for hearing before a Division Examiner on April 19, 2001. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Prehearing Statement three days in advance of a scheduled hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party

will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.
