


Ladies and Gentlemen:

This application has been set for hearing before a Division Examiner on April 5, 2001, at the Oil Conservation Division hearing room, located at 1220 South Saint Francis Drive, Santa Fe, NM 87504. Failure to appear at that time and become a party of record will preclude you from challenging these matters at a later date.

This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.
