### **APPLICATION**

CONCHO RESOURCES, INC. ("Concho"), through its undersigned attorneys, hereby makes application pursuant to the provisions of N.M.Stat.Ann. § 70-2-17, (1978), for an order pooling all formations from the surface to the base of the Morrow formation in the following described spacing and proration units in the W/2 of Section 11, Township 16 South, Range 27 East, N.M.P.M., Eddy County, New Mexico:

- A. the W/2 for all formations and/or pools developed on 320-acre spacing and proration units which includes but is not necessarily limited to the Diamond Mound-Morrow Gas Pool; and
- B. the SW/4 for all formations and/or pools developed on 160-acre spacing and proration units which includes but is not necessarily limited to the Undesignated Southeast Diamond Mound-Grayburg Gas Pool.

In support of its application, Concho states:

- 1. Concho Resources, Inc. is a working interest owner in the W/2 of Section 11 and has the right to drill thereon.
  - 2. Concho proposes to dedicate the above-referenced spacing or proration units to

its Fargo "11"Federal Well No. 1 to be drilled at a standard location 660 feet from the South and West lines (Unit M) of said Section 11, to an approximate depth of 9,200 feet to test any and all formations from the surface to the base of the Morrow formation.

- 3. Concho has sought and been unable to obtain either voluntary agreement for pooling or farmout from certain interest owners in the subject spacing units identified on Exhibit A to this application.
- 4. Said pooling of interests will avoid the drilling of unnecessary wells, will prevent waste and will protect correlative rights.
- 5. In order to permit the Concho Resources, Inc. to obtain its just and fair share of the oil and gas underlying the subject lands, all mineral interests should be pooled and the proposed well should be drilled.

WHEREFORE, Concho Resources, Inc. requests that this application be set for hearing before an Examiner of the Oil Conservation Division on April 19, 2001 and, after notice and hearing as required by law, the Division enter its order:

- A. pooling all mineral interests in the subject spacing and proration units,
- B. designating Concho Resources, Inc. operator of these units and the well to be drilled thereon.
- C. authorizing Concho Resources, Inc. to recover its costs of drilling, equipping and completing the well,
- D. approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to

the COPAS accounting procedures, and

E. imposing a penalty for the risk assumed by Concho Resources, Inc. in drilling and completing the well against any working interest owner who does not voluntarily participate in the drilling of the well.
