### APPLICANT

Range 34 East, N.M.P.M., Lea County, New Mexico, and proposes to dedicate the above-described spacing or proration unit to its Buckeye No. 1 Well to be re-entered at a standard location 660 feet from the north line and 1980 feet from the west line of Section 15, to a depth sufficient to test any and all formations down to the base of the Bone Springs Formation.
