Yates Petroleum Corporation seeks an order pooling all mineral interests from the surface to the base of the Morrow formation in the following described spacing and proration units located in Section 13, Township 15 South, Range 34 East: S/2 to form a standard gas spacing and proration unit for all formations and/or pools developed on 320-acre spacing within that vertical extent which includes but is not necessarily limited to the Undesignated Morton-Morrow Gas Pool; SW/4 to form a standard gas spacing and proration unit for all formations and/or pools developed on 160-acre spacing within that vertical extent; the N/2 SW/4 to form a standard spacing and proration unit for all formations and/or pools developed on 80-acre within that vertical extent which includes but is not necessarily limited to the Undesignated Morton-Wolfcamp Pool; and NE/4 SW/4 form a standard 40-acre spacing and proration unit for all formations and/or pools developed on 40-acre spacing and proration units which includes but is not necessarily limited to the Undesignated Grassland-Wolfcamp Pool. Said units are to be dedicated to the Chevy AWV State Com Well No. 1 to be drilled at a standard location 1650 feet from the South and West lines of said Section 13 to a depth sufficient to test all formations from the surface to the base of the Morrow formation. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Yates Petroleum Corporation as operator of the well and a charge for risk involved in drilling said well.
