## STATEMENT OF CASE

### APPLICANT

Applicant seeks an order pooling all mineral interests from the surface to the base of the Abo formation underlying the following described acreage in Section 20, Township 5 South, Range 25 East, in the following manner: the NW/4 to form a standard 160-acre spacing unit for all formations and/or pools developed on 160-acre spacing within that vertical extent which presently includes but is not necessarily limited to the Pecos Slope-ABO Gas Pool, SW/4 NW/4 to form a standard 40 acre spacing and proration unit for any and all formations and or pools developed on 40 acre spacing within that vertical extent. Said unit is to be dedicated to Applicant's proposed Rose Federal Well No. 15 to be located at a standard location in Unit E of this section. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof, actual operating costs and charges for supervision, designation of Applicant as operator of the well, and a charge for risk involved in drilling and completing this well. This unit is located approximately 48 miles north and east of Roswell, New Mexico.


