

CASE 12703: In the matter of the hearing called by the Oil Conservation Division for an order creating and extending certain pools in Chaves and Lea Counties, New Mexico.

(a) CREATE a new pool in Chaves County, New Mexico classified as a gas pool for Morrow production and designated as the Northwest Anderson Ranch-Morrow Gas Pool. The discovery well is the Texaco Exploration and Production, Inc. Dulce 36 State Com Well No. 1 located in Unit F of Section 36, Township 15 South, Range 31 East, NMPM. Said pool would comprise:
