- 1. My name is Colin Wasteneys. I reside in Buffalo, New York. I am a senior geologist employed by URS Corporation.
- 2. URS Corporation provides environmental consulting services to BP Amoco concerning the remediation of approved wastes at its Crouch Mesa Centralized Waste Management Facility located in the SW/4 SE/4 of Section 2, Township 29 North, Range 12 West, NMPM, San Juan County, New Mexico.
- 3. The Crouch Mesa Centralized Waste Management Facility was approved by the Oil Conservation Division by OCD Rule 711 Permit Approval NM-02-0003 authorizes BP Amoco to accept certain oilfield wastes that are generated in New Mexico.
- 4. OCD Rule 711 Permit Approval NM-02-0003 authorizes the Crouch Mesa Centralized Waste Management Facility to accept exempt and non-hazardous non-exempt oil field wastes that are generated in the State of New Mexico by Amoco Production Company. Pursuant to this permit BP Amoco conducts land farming operations at this facility
- 5. BP Amoco seeks authorization to bring to this facility for remediation crude oil contaminated soils from five former BP/Amoco crude oil pump stations which are part of the former Line 90 crude oil pipeline that runs from Bisti, New Mexico to Long Beach, California. Three of these pump stations are located outside of New Mexico.
