5 There was also a Case 12,459. This was the
6 Application of the Oil Conservation Division for an order
7 requiring I.T. Properties to properly plug one well in Eddy
8 County, New Mexico, and this case has also been continued.
9 It will be heard at the Commission Hearing on November 6th.
