Please be advised that the attached order has been entered by the New Mexico Oil Conservation Division ("OCD") in the referenced case, requiring you to bring eight (8) wells into compliance with OCD Rules within thirty days from January 9, 2002, and assessing a civil penalty in the amount of \$12,000 for past and current non-compliance.

You should be further advised that failure to comply with provisions of the order requiring you to bring your wells into compliance may result in assessment of further penalties.
