**ASSIGNMENT OF CONTRACT AND OIL AND GAS OPERATING RIGHTS
(Sundance Prospect)**

STATE OF NEW MEXICO

COUNTY OF LEA

This Assignment of Contract and Oil and Gas Operating Rights is effective April 1, 2001 by and between TrinAca Investment Corporation, a New Mexico corporation ("TrinAca"), whose address is P.O. Box 2325, Corrales, New Mexico 87048 ("Assignor") and the parties named below (collectively "Assignees").

WHEREAS, Assignor owns certain contract and operating rights and interests in and under that certain Exploration Drilling Agreement between Manzano Oil Corporation, Sun Valley Energy Corporation and TrinAca Investment Corporation dated June 21, 1997, and under that certain Operating Agreement between Manzano Oil Corporation as Operator, and TrinAca Investment Corporation and others as Non-Operators, dated March 10, 1997, covering the following described lands located in Lea County, New Mexico: All of Section 1, Township 16 South, Range 33 East, N.M.P.M.; Lots 1 through 16 of Section 6, and the N/2 of Section 7, Township 16 South, Range 34 East, N.M.P.M.; together with all rights attributable thereto (the rights and interests in and under such agreements which are vested in Assignor are collectively referred to as the "TrinAca Contract and Operating Rights").

NOW, THEREFORE, for TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby grants, transfers, assigns and conveys to the parties named below, the percentage set forth next to their names of the TrinAca Contract and Operating Rights:
