#### STATEMENT OF CASE

Applicant seeks an order expanding the Indian Basin-Upper Pennsylvanian Associated Pool (the "Associated Pool") to include certain designated acreage (the "extension area") and to contract the Indian Basin-Upper Pennsylvanian Gas Pool (the "Gas Pool") by deleting therefrom that same acreage. Applicant also seeks an exception to the special rules and regulations for the Associated Pool for the extension area. The special rules and regulations for the Associated Pool allow one well per 80-acre tract. Applicant requests that only one well be allowed per quarter section in the extension area.

Yates presently operates two wells in the NW/4 of Section 12, T-22-S, R-23-E, which is within the extension area and therefore affected by Applicant's proposed modification to the special pools rules and regulations for the Associated Pool. Yates does not oppose this application, so long as the NW/4 of Section 12 is grandfathered-in and Yates is allowed to continue to operate both of these wells in this quarter section.
