Dear Ms. Wrotenbery:

On behalf of San Juan Resources, Inc. and in accordance with the provisions of the referenced order, I am requesting an extension of the commencement date for this well which is currently set to expire on November 1, 2002 and in support state:

- (1) This pooling order pools the interest of Mr. Frank A. King which is 5/63 % in the Mesaverde formation for this downhole commingled wellbore;
- (2) The order was entered effective April 17, 2002 and provides that this well shall be commenced on or before July 31, 2002;
- (3) By letter dated June 17, 2002, I requested an to November 1, 2002 in order to resolve a contract dispute with a party not current subject to this pooling order.


(4) George Taoka, a partner in certain wells drilled and operated San Juan Resources, signed a letter agreement in May, 2001 to farmout his interest in the spacing unit for the referenced well. Mr. Taoka died in December, 2001 and his successor is not honoring the letter agreement. San Juan Resources, Inc. is initiating suit in San Juan County, New Mexico over this matter as indicated in a letter dated October 16, 2002 from San Juan Resources's litigation attorney. **See Enclosure (1)**

(5) The Taoka interest is estimated by me to involve a 23 % to 26.50 % working interest in this spacing unit.

(6) Do to this situation, San Juan Resources, Inc. request an extending of the spudding deadline for this well until the litigation is resolved.

(7) An extension of the commencement date for this well will avoid the necessity of having to commence a new pooling case for this well.
