Dear Mr. King,

San Juan Resources, Inc. (SJR) is going to drill a well deep enough to penetrate the lower Dakota formation by the end of the year. We will test both Dakota and Mesa Verde formations and attempt completions in both zones. Our plans are to commingle production in the two zones, MV and DK. We enclose a JOA, an AFE for the Kaempf #1E well, an exhibit indicating your interest between the base of the PC and the top of the DK, and a copy of a drill site plat.

Our records indicate that you are owner of the minerals between the Base of the Pictured Cliffs formation and the top of the Dakota Formation. You assigned your minerals to A. D. Mammel in the Dakota. In a telephone conversation two weeks ago with our office, you indicated that you wanted to participate in this well we are proposing. We hope that this information is what you need to determine your commitment to this well. In addition, please verify that this is the interest you own in the above referenced drill site.

The exhibit we enclose attached to the AFE indicates your interest in the non-DK zones below the base of the PC. We have included in the JOA a cost allocations provision, designed by some San Juan Basin companies who work together. If you will read this provision carefully, you will see how SJR will allocate expenses between the two zones, since we have non-equal ownership between the MV and DK. We will need to have you sign the JOA *prior* to SJR's spudding the Kaempf #1E well, so that we know as to your commitment to this well.
