Re:

You will recall that Permian Resources, Inc. appeared in Case No. 12663 opposing David H. Arrington Oil and Gas, Inc.'s application for an unorthodox location and simultaneous dedication for its Mayfly "14" State Well No. 7. Permian's opposition was based on seismic and the available subsurface geologic data obtained from the NW/4 of Section 13 supporting its contention that the Arrington well would drain Strawn formation reserves owned by Permian in Section 13 offsetting the proposed unorthodox location. On September 11, 2001, following the hearing in the case, the Division entered Order No. R-11646 denying Arrington's Application.

Since the issuance of Order No. R-11646, Permian drilled its Hillburn No. 3 well to two separate bottom-hole locations in the NW/NW of Section 13. Data from that well confirms that the Strawn interval that is being produced by Arrington's Mayfly "14" State Com No. 2 well in the NE/4 of Section 14 is not present in either of the Hillburn No. 3 well bottom-hole locations. Consequently, it does not appear that the unorthodox location sought by Arrington for its Mayfly "14" State No. 7 well would adversely affect Permian's correlative rights in the adjoining section. Permian therefore supports Arrington's Application in Case No. 12808 and hopes to see Arrington complete a successful well.

Although it opposed Arrington's Application in Case No. 12663, Permian believes that by denying the Application, the Division acted properly to protect the correlative rights of the offsetting interest owners, based on the best geologic and engineering data available at the time. We appreciate the Division's decisive action in this vigorously contested matter.
