APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN CHAVES AND EDDY COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on February 7, 2002, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this 22nd day of February, 2002, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Chaves County, New Mexico classified as a gas pool for Atoka production, bearing the designation of Broke Tank Lake-Atoka Gas Pool. The Broke Tank Lake-Atoka Gas Pool was discovered by the Nadel & Gussman Permian LLC Moon Company Trust Well No. 1 located in Unit N of Section 25, Township 8 South, Range 29 East, NMPM, which was completed in the Atoka formation on September 17, 2001. The top of the perforations is at 8,458 feet.
- (3) There is need for the creation of a new pool in Eddy County, New Mexico classified as a gas pool for Atoka-Morrow production, bearing the designation of Crooked Canyon-Atoka-Morrow Gas Pool. The Crooked Canyon-Atoka-Morrow Gas Pool was discovered by the KUKUI Operating Company Sargent Canyon "31" Federal Well No. 1 located in Unit O of Section 31, Township 19 South,

Range 21 East, NMPM, which was completed in the Morrow formation on October 20, 2001. The top of the perforations is at 6,963 feet.

- (4) There is need for the creation of a new pool in Chaves County, New Mexico classified as a gas pool for Pre-Permian production, bearing the designation of Northeast Foor Ranch-Pre-Permian Gas Pool. The Northeast Foor Ranch-Pre-Permian Gas Pool was discovered by the Yates Petroleum Corporation Fawn "A'VN" State Com. Well No. 1 located in Unit K of Section 17, Township 8 South, Range 27 East, NMPM, which was completed in the Cisco formation on July 26, 2001. The top of the perforations is at 6,442 feet.
- (5) There is need for the creation of a new pool in Eddy County, New Mexico classified as a gas pool for Morrow production, bearing the designation of West Gardner Draw-Morrow Gas Pool. The West Gardner Draw-Morrow Gas Pool was discovered by the Yates Petroleum Corporation Bullis "AVW" State Com. Well No. 1 located in Unit C of Section 20, Township 19 South, Range 20 East, NN PM, which was completed in the Morrow formation on May 15, 2001. The top o`the perforations is at 6,484 feet.
- (6) There is need for the creation of a new pool in Eddy County, New Mexico classified as a gas pool for Wolfcamp production, bearing the designation of Remuda-Wolfcamp Gas Pool. The Remuda-Wolfcamp Gas Pool was discovered by the Texaco Exploration and Production, Inc. Remuda Basin "24" State Well No. 1 located in Unit N of Section 24, Township 23 South, Range 29 East, NMPM, which was completed in the Wolfcamp formation on August 5, 2001. The top of the perforations is at 11,546 feet.
- There is need for certain extensions to the Avalon-Morrow Gas Pool, the Avalon-Strawn Gas Pool, the Brushy Draw-Delaware Pool, the South Carls bad-Morrow Gas Pool, the East Catclaw Draw-Delaware Pool, the East Cedar I ake-Morrow Gas Pool, the North Cedar Lake-Morrow Gas Pool, the Cedar Lake-Yeso Pool, the West Corral Canyon-Delaware Pool, the Crow Flats-Morrow Gas Poo, the South Empire-Morrow Gas Pool, the Grayburg-Morrow Gas Pool, the North Hackberry-Morrow Gas Pool, the Indian Basin-Upper Pennsylvanian Assoc ated Pool, the Ingle Wells-Delaware Pool, the Little Box Canyon-Morrow Gas Pool, the Malaga-Bone Spring Pool, the South Millman-Morrow Gas Pool, the Nash Draw-Atoka Gas Pool, the Nash Draw-Delaware Pool, the East Penlon-Bone Spring 'ool, the Southwest Ross Draw-Wolfcamp Gas Pool, the South Sand Dunes-Delaware Pool, the Scoggin Draw-Morrow Gas Pool, the Travis-Wolfcamp Pool, and the Southeast Willow Lake-Bone Spring Pool, all in Eddy County, New Mexico; an I the Comanche-Wolfcamp Gas Pool, the Foor Ranch-Pre-Permian Gas Pool, the Foor Ranch-Wolfcamp Gas Pool, the Northwest Foor Ranch-Wolfcamp Gas Pool the Springer Basin-Atoka-Morrow Gas Pool, and the South Wolf Lake-San Andres Pool, all in Chaves County, New Mexico.

IT IS FURTHER ORDERED THAT

- (1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowabe in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.
- (2) The effective date of this order and all creations and extensions included herein shall be March 1, 2002.
